Improving recovery rates

Up to speed on new developments

The practice continues to expand its portfolio of IRIS solutions where these will add value to its work. It offers KashFlow online accounting software, which clients log into via the practice website.

Danny says, "KashFlow is beneficial to a growing number of our clients and feedback has been very positive; they find it easy to use. As KashFlow integrates nicely into IRIS, sending figures through to IRIS Accounts Production, we feel it will come into its own during the end-of-the-year busy season by simplifying the process of preparing final accounts."

Even the practice website is now maintained by IRIS. Aryeh notes, "We're just in the process of refreshing our website and the IRIS OpenWebsite service team have been very quick at implementing the changes." The practice is also currently moving from Sage to IRIS for its payroll software.

Melinek Fine keeps a watching brief on the growing IRIS portfolio of cloudbased solutions: Danny says, "We're pushing forward on IRIS OpenSpace for cloud-based document exchange and approval. It's definitely the way to go."

Reflecting on the relationship with IRIS, now in its sixth year, Danny says, "IRIS has looked after us very well, both in terms of managing the relationship and providing technical support.
