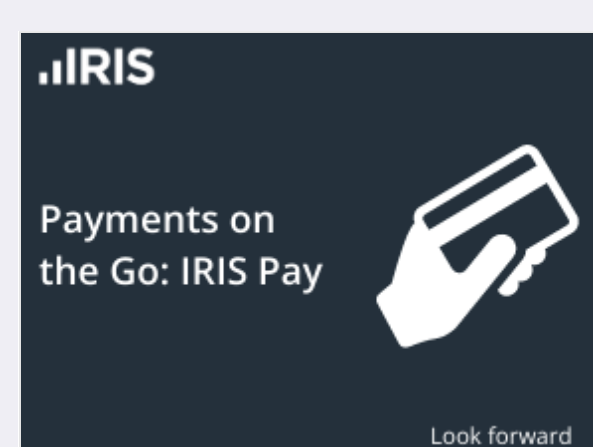

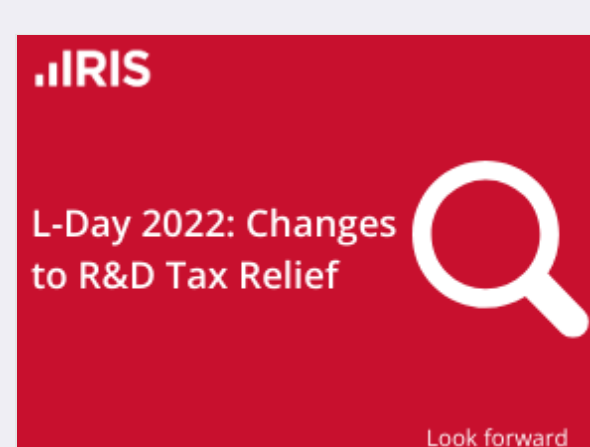

L-Day 2022: Changes to Research and Development (R&D) tax relief

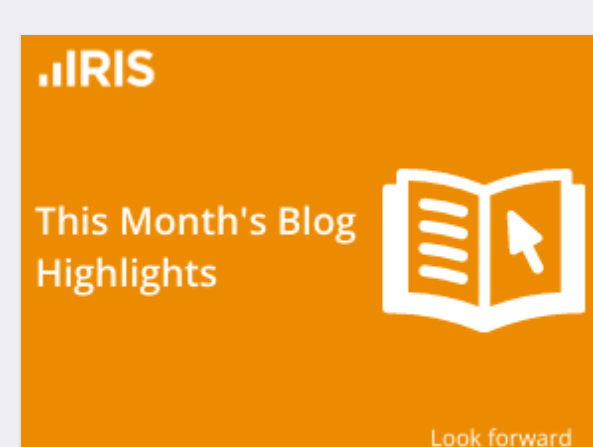

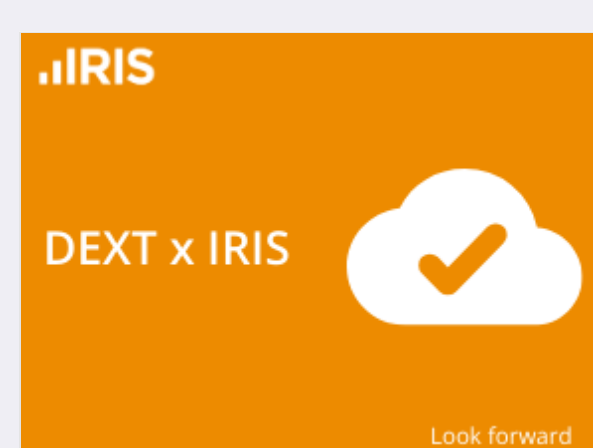

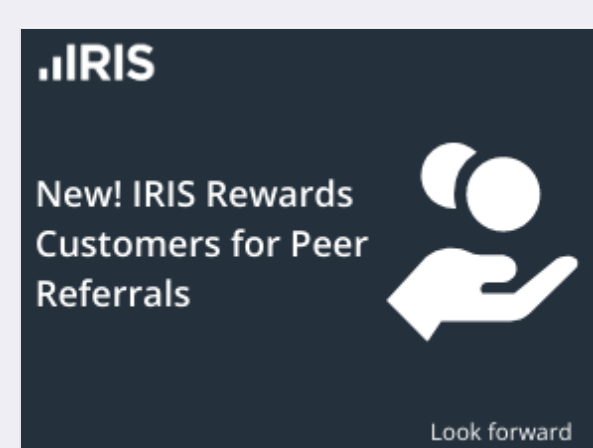
