

The Suitability of Model Articles of Association for Single Director Companies

A recent High Court judgement has cast doubt over the effectiveness of the generally accepted and widely used Model Articles of Association for single director companies.

The general understanding has been that Model Article 7(2) overrode Model Article 11(2). In the case of Hashmi v Lorimer-Wing, the High Court found that this is not the case and that under the Model Articles, a company requires a minimum of two directors to correctly function.

It would be prudent, therefore, for single director companies to review their Articles and take action where necessary.
