### MTD update

The delay is official. The mandation of MTD for ITSA will now be introduced from April 2026, with businesses, self-employed individuals, and landlords with income over £50,000 mandated to join first. Those with income over £30,000 will be mandated from April 2027.

The government understands the challenging economic environment businesses and self-employed individuals are facing so they have announced more time to prepare so they can adapt to the new ways of working.

A significant part of the Economic Crime and Corporate Transparency Act and subsequent Companies House reform is the introduction of identity verification. This means that when setting up new companies, directors and persons of significant control will need to go through an identity verification process. For existing companies, directors and

PSCs will need to verify their identity

within a set period.

Accountants and other professionals providing company secretarial services to their clients will need to register themselves as an Authorised Corporate Service Provider with Companies House. This should be a straightforward process for those already registered with a supervisory body for anti-money laundering (AML) purposes.




