





19th - 22nd July 2023 - National Insurance:

If you pay by cheque, any Class 1A National Insurance owed on expenses or benefits for the previous tax year must reach HMRC by **Wednesday 19th of July**.


If you pay electronically, they must reach HMRC by **Saturday 22nd of July.**

31st July 2023 - PAYE Settlement:

You must submit PAYE settlement agreements (PSA) for 2022/23 by **Monday 31st of July.**


