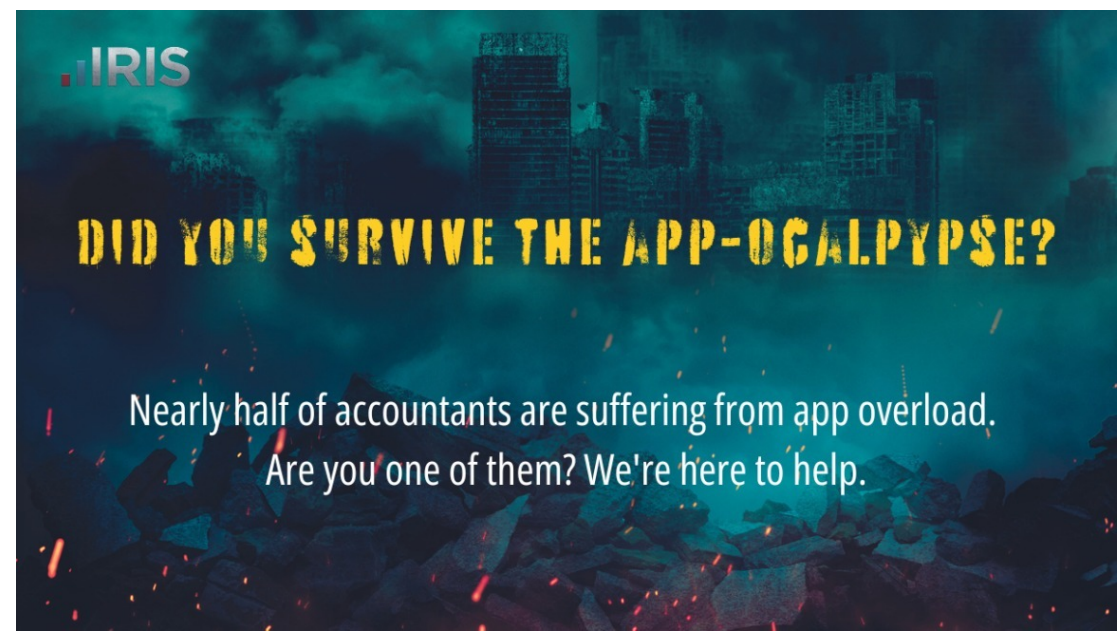

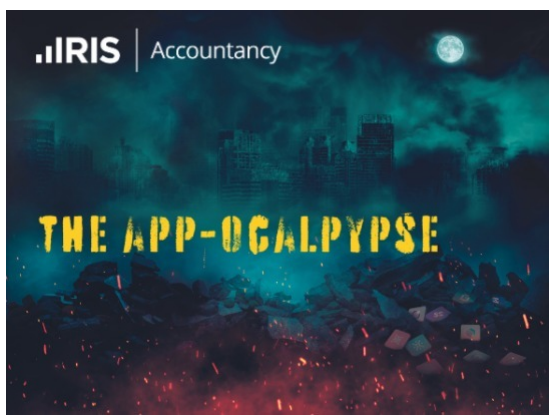

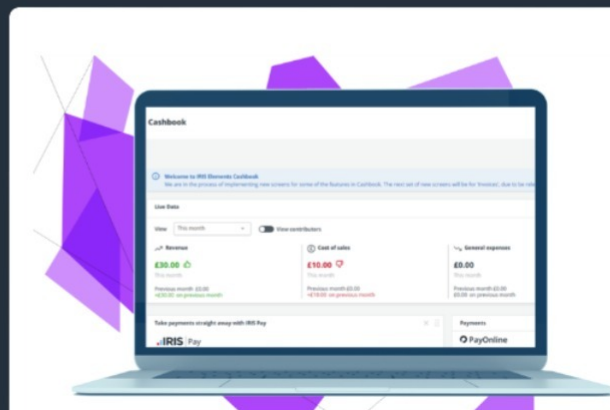


Accountancy firm puts hybrid working at the heart of its practice
