Economic Crime and Corporate Transparency Act

The quality and accuracy of the information on public record for the 5 million registered companies has long been questioned. Now those concerns will be addressed, starting from the 4th March (secondary legislation pending). The first changes will include:

- Providing a registered email address at incorporation or on the next Confirmation Statement
- Only allowing appropriate registered office addresses – PO Boxes are no longer allowed
- Lawful purpose statement on submissions.
